

Dear Kinetix Tennis Contract Time Member,

In an ongoing effort to continually improve the efficiency and effectiveness of our facility, we wanted to take a moment to highlight some of the upcoming adjustments to the 2021/2022 Contract season.

We have implemented a new standard time frame for contract schedules. This will allow all courts to begin and end in a more orderly fashion while allowing all programs to focus on energy conservation while maximizing court usage. This means that you may see a slight adjustment in the start and end times available for your desired times. For all contracts, this is a necessary adjustment however no contract times are adjusted more than 30 min earlier or later.

Secondly, we are only offering contract times in spaces where we have ample court space to sell. This will allow us to maximize our space for contract time as well as our teaching and programming hours while providing potentially quieter times for those playing who are not accustomed to having to play next to a teaching court.

Thirdly we are able this year to offer a 32 week season for contract times with 16 weeks before the Christmas break and an additional 16 weeks after the New Year.

Finally, we wanted to take a moment to thank everyone for their continued support and dedication to keeping our facility clean and COVID free during this tumultuous year. Our staff, members and community all benefit when everyone does their part.

Application Procedure & Program Rules

- **Contracts run from Thursday, September 2, 2021 through Thursday, December 23, 2021. There will be no contract play Friday, December 24, 2021 through Saturday, January 1, 2022. Contract time will resume Sunday, January 2, 2022 and continue through Saturday, April 23, 2022.**
- No applications or renewals will be accepted over the phone.
- A separate application for each time slot is required.
- The Group Captain is responsible for all information provided on the application. They will be the ***ONLY*** person billed for all indoor court time and membership fees. **The Club is not responsible for collecting fees from other group members.**
- All primary group players must be listed on the application. Each contract time slot must contain a minimum of two members and be signed by the contract captain or the application is not considered complete. Failure to list the names of all group players on the application will result in forfeiture of time slot for next season. Groups renewing a contract from the current contract season will be given priority.
- Contract deposits are due no later than **April 15, 2021**. Contract deposits are \$500 per contract. Deposits are nonrefundable.
- Contracts are eligible for an additional 2% discount if all completed paperwork, deposits and fee's (including membership dues for all players) are paid in full by **April 30, 2021**.
- Please note, renewal applications for the 2021-2022 indoor seasons are not guaranteed. Please have your completed applications in to the Welcome Center of Kinetix no later than **May 30, 2021**. Only the renewal applications received through the 30th of May will be considered for the available time slots. A waiting list will be created for time slots that are not renewed on time or that have previously been unreserved.
- **Cancellation Fee:** A 50% cancellation fee will be collected if you withdraw from your contract and Kinetix Tennis cannot re-sell your contracted time.
- Beginning on June 1, all courts not previously renewed or reserved for Kinetix Tennis programming will be assigned on a first-come, first-served basis. All applicants for time slots should submit their applications as soon as possible.
- Captains of new contracts will be notified of contract assignments.
- There is no contract time on Thursday, November 25, 2021 for the Thanksgiving Day holiday.
- All Contract players must have a Kinetix Tennis Membership during the contract season. If a player plays/subs more than ONE time they must have a membership. If a player does not pay membership dues then a club suspension will occur until the membership is paid in full.
- Payment of DEPOSIT, FEES AND/OR MEMBERSHIP DOES NOT GUARANTEE A SPECIFIC COURT OR TIME OR AVAILIBILITY as Kinetix Tennis reserves the right to adjust any courts assignments to maximize the schedule.
- Only members of the Club's professional tennis staff are authorized to give lessons for a fee on Club premises.
- No food (with the exception of sports energy bars), and no drinks in glass containers or cans are permitted on the tennis courts.
- Members are responsible for their guest's compliance with all club rules, including wearing of proper attire and for any charges they may incur. Violation of club rules by guests will be considered violation of club rules by the member host.
